

UDS March Madness: How to Use UDS Meaningfully

What is UDS? Uniform Data System is a standardized reporting system that provides consistent information about health centers and look-alikes. BUT IT CAN BE MORE!

What happens in February? Any reporting changes for UDS reports of the prior year are due by February 15

Now what??? You spend all this time ensuring your reporting is accurate, so now what do you do with the data? Just submitting the report and checking it off your to do list is NOT using UDS meaningfully. Use these reports to enhance the performance of your health center.

- Use your data as a benchmark for future performance
- Use your data to drive you clinical, financial and operational decision making using more than tables 6 and 7
- Compare your UDS performance to like Health Centers
- Use UDS to assist you in PCMH
- Identify any trends (good or bad) and utilize that for staff training
- Waiting until the last minute to submit your UDS reports can be very strenuous on all staff and can result in errors. Help and Information is available year-round so that you can be ahead of the game in keeping your UDS reporting accurate.
